



Florida SB 846 Explainer

What is Florida SB 846?

Florida SB 846, which took effect on July 1, 2023, restricts Florida's public colleges and universities from "accepting grants from or participating in partnerships or agreements" with individuals or schools from countries identified as "countries of concern," which include China, Russia, Iran, North Korea, Cuba, Venezuela and Syria.¹

This restricts the ability of Florida's public colleges and universities to hire researchers and graduate assistants from these countries. The law provides for an approval process on a case by case basis, where the educational institution is required to submit a form requesting approval. The state Board of Governors must then determine whether the partnership or agreement is (a) valuable to the students and the institution, and (b) not detrimental to the safety or security of the United States or its residents.

Who does this law impact?

The law restricts the hiring of individuals who are "domiciled" in a "country of concern" and who is not a U.S. citizen or green card holder.² For the purposes of the law, "domiciled" means individuals who are physically present in a foreign "country of concern" and who intend on returning to that country.³

The Board of Governors' guidance document explains that the law applies to activities including hiring a individual from a country of concern for "academic, administrative, research purposes, or research scholars," "[c]ollaborating with a foreign principal on a research project in furtherance of the university's mission," "sharing data," as well as "[l]icensing intellectual property for academic or research purposes" to or from a foreign principal.⁴ According to the guidance, the law does not apply to student enrollment.



What's at stake?

This law would chill Florida's public colleges and universities from recruiting and hiring talented international graduate assistants and researchers, many of whom are from China and Iran. At the University of Florida, for example, a significant share of international graduate students are from China,⁵ and the law would have an outsized impact on these communities.

In addition, SB 846 restricts scientific collaboration by requiring approval for licensing intellectual property, sharing research data, and collaborating with researchers from the countries of concern. This would have a chilling effect on open science, and could harm scientific innovation and scientific leadership in Florida and the U.S. more broadly.
